1)	24/0728/FUL Amy and Jamie Wood	Demolition of garage, construction of side and rear extension. 5 Orchard Close, OSM, EX11 1HT
<b>Town Council Comments:</b> The Town Council support this application on the basis that swift boxes/bricks are installed and rain water is harvested. The Town Council are however, concerned with the loss of a parking space in a small cul-de-sac.		
2)	24/0998/LBC Mr David Armour	Proposed roof refurbishment, first floor study gallery with roof window, partial roof and wall insulation, replacement doors and windows and external render replacement. Deblins Brook Farm, Sandgate Lane, Wiggaton, OSM, EX11 1PX
<b>Town Council Comments:</b> The Town Council do not support this application. Evidence has not been provided to show that all repair options for the windows and doors have been exhausted.

If the windows are beyond repair, the prototype should be inspected by the conservation officer. The Town Council are concerned that the window is a double glazed unit. The Town Council are also concerned with the number of changes being proposed.

3)	24/0230/LBC	Mr Ben Smith	Introduce a French drain to the front and sides of the building. Infill brick gateway to front garden wall. Replace 4no. timber windows at ground floor on North Elevation (rear) with double glazed timber windows and 1no. on west elevation. Rebuild 1no. chimney stack and install new chimney pot on west elevation and install new chimney pot on east elevation. Re-roof rear lean-to with galvanised steel roof sheeting and install 2no. rooflights on north elevation. Interior: Form new opening with door from living room to playroom snug. Halls Farm, Higher Metcombe, OSM, EX11 1SS
<p><b>Town Council Comments:</b> The Town Council do not support this application. The application has not fully addressed the issues previously raised by the EDDC Planning Officer and the Historic England Officer.</p>			
4)	24/1054/FUL	Mr & Mrs Elston & Collinson	Proposed demolition of existing conservatory and construction of single storey rear extension. Garden Close, Yonder Street, OSM, EX11 1HH
<p><b>Town Council Comments:</b> The Town Council support this application. We would actively encourage the harvesting of rain water.</p>
